TBSA- 25% DEEP THERMAL BURN

HISTORY

Master.Nazm,6 years old male, patient was admitted in this hospital with A/H/O burn injury at home at 7 AM on 02.09.2019 as told by attendants while baby playing at home fall in the hot tea.

ON EXAMINATION

GC - Sick, No Pallor, No icterus, No cyanosis, No clubbing No oedema.

Pulse - 130/Min R/S - B/L clear Temp - 98.4°F,

CVS - NAD CNS - NAD PA - Soft, Bs+ R/R - 26/Min.

SPO2 - 97% GCS - 15/15 Wt-15 KG

INVESTIGATION

All the Investigation Reports are attached with Discharge Summary.

COURSE IN HOSPITAL

Patient admitted in hospital through casually on 02.09.2019 under Dr.Verma, with above mentioned complaints. After Initial evaluation as per standardised protocol treatment initiated with IV fluids, IV Antibiotics, Antipyretic, Analgesic, Antacid and other supportive treatment also given. All necessary investigations were done. Patient managed conservatively + multiple antiseptic dressing done. Paediatric referrals (Dr.NEERA) were done. Treatment optimized accordingly. Now patient condition is stable a febrile, pass urine and stool, taking orally well and is being discharged on following advice and medication.
