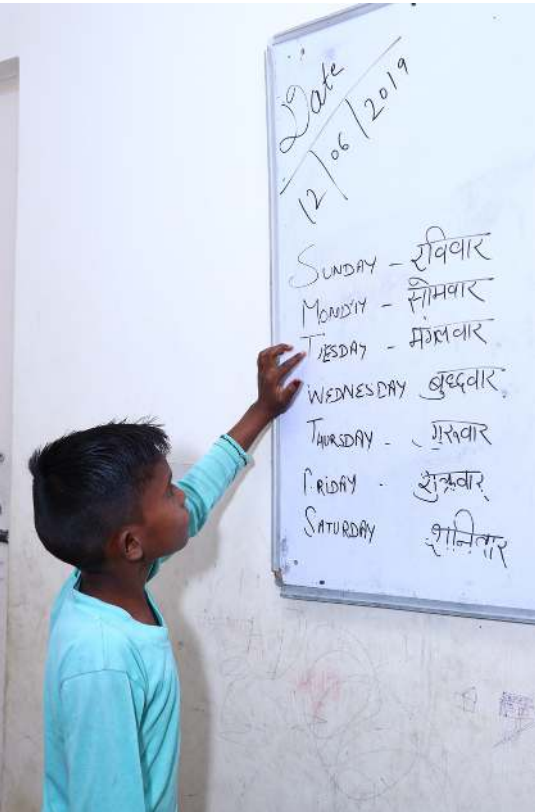

HISTORY

Master Kaushal, 1 year's 8 Month old male patient brought to causality, history of burn injury by hot milk at 8 PM on 28.05.2019 at home took primary treatment at Bhardwaj Hospital then came to Vinayak Hospital with complaints of pain at burn site.

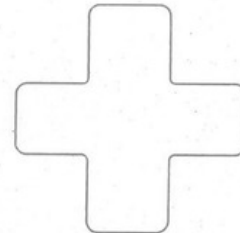
